Tier One:

First Violation: Warning Letter or email, to correct listing within two (2) days

Second Violation: \$50 to \$250, with notification of date listing is subject to removal. Attend Class in Lieu of Fine (if such class is offered by AOR/MLS).

Third and Subsequent Violations: \$50 to \$250, with the listing removed and/or referred to the MLS Committee.

Tier Two:

First Violation: Warning Letter or email to correct listing within 2 days.

Second Violation: \$50 to \$250 with notification of date listing is subject to removal.

Third and Subsequent Violations: \$50 to \$250, with listing removed and/or referral to MLS Committee.

Tier Three:

First Violation: Warning Letter or email to correct listing within 2 days.

Second Violation: \$50 to \$250, with notification of date listing is subject to removal.

Third and Subsequent Violations: \$50 to \$250, with listing removed and/or referral to MLS Committee
